

Financial Aid and Scholarships Terms and Conditions

Terms and Conditions of Your Financial Aid

By accepting the financial aid offered to me, I acknowledge that I understand and agree to the following terms and conditions, as well as certify that I meet the below requirements.

Disbursement of Aid

- I understand that if enrolled 10 days prior to the first day of classes, and any day thereafter, that my financial aid for that semester, if available for disbursement, will automatically be applied toward my student account with Student Business Services.
- I understand that if I decide not to attend Texas State University, I must officially [withdraw](#) through the Registrar's Office. If I do not officially withdraw prior to the first class day, I will be considered to be enrolled. If I withdraw from the University once classes have begun or fail to receive earned grades in courses that span the entire period I am scheduled to complete during a semester, I will be responsible for repayment of all or a portion of my financial aid.

Required Actions

- I understand that I must accept my financial aid offers before funds will be available.
- I understand that offers not accepted within three weeks of my being sent an offer notification (email or mail) will be cancelled and will not be reinstated.
- I will notify Financial Aid and Scholarships of any outside resources (such as scholarships or waivers) not listed on my award via the [Resources/Additional Information](#) tab on Texas State Self Service.

Potential Repayment of Aid

- I understand that Financial Aid and Scholarships may be required to adjust my aid if there are any changes in enrollment status, housing status or other aid received.
- I understand that my aid and cost of attendance are based on full-time enrollment. I also understand that if I plan to enroll less than full time that I must complete and submit an Enrollment Change Form so that my aid and cost of attendance can be adjusted.
- I understand that if I am not enrolled at least full time, or as otherwise indicated on my Enrollment Change Form, on the census date for the semester (i.e., 12th class day of each fall and spring semester and the 4th class day in July for the summer semester), I may be required to repay all or a portion of the aid that I have already received.

- I understand that if I am a Pell Grant, Iraq Afghanistan Service Grant (IASG) or TEACH Grant recipient, federal regulations require me to be attending the courses for which I am enrolled. If I am dropped from a course for not beginning attendance, my grant will be adjusted or cancelled, as appropriate, based on the courses I am attending.
- I understand and agree that if my eligibility for Direct Subsidized Loans subsequently changes after I have been offered aid, Financial Aid and Scholarship has my consent to replace the amount with Direct Unsubsidized Loans up to the original accepted amount.

Eligibility

- I understand that my enrollment status for financial aid eligibility is based on only those courses that count toward my degree.
- I understand that I must maintain my eligibility for financial aid. I further understand that the Satisfactory Academic Progress (SAP) policy can be viewed by visiting Maintain My Eligibility ([undergraduate](#) or [graduate](#)).
- I understand that I must be enrolled at least half time in an undergraduate or graduate degree-seeking or post-baccalaureate teacher certificate program to be eligible for most types of financial aid.
- I understand that if I retake a previously passed course for the second or subsequent time, the course is not aid eligible. If I am enrolled in such hours on the census day (i.e., 12th class day of each fall and spring semester and the 4th class day in July for the summer semester), my aid-eligible enrollment will be reduced, and I may be required to repay any aid that I received for such courses.
- I certify I am not incarcerated.

Availability of Funds

- I understand Texas State is permitted to apply my federal, state and institutional financial aid to my tuition, fees, room and board charges.
- I understand that funds are offered on a first-come first-served basis and the priority deadline to submit my FAFSA each year is January 15. Additionally, some funding is only available to students who are also admitted to the University by January 15.
